#### ORDER:

- 1. The Government, in the reference 1<sup>st</sup> read above, has established a dedicated Corporation namely "Andhra Pradesh State Development Corporation Limited (hereinafter referred as "APSDC" or "the Corporation") as a 100% State owned Public Limited Company incorporated under the Companies Act 2013 with the mandate of planning, funding and financing social and economic development projects and activities in the State of Andhra Pradesh.
- 2. The Government, in the reference 2<sup>nd</sup> cited above, also promulgated the Andhra Pradesh Ordinance No. 14 of 2020 (hereinafter referred to as "Ordinance") to provide statutory status and strengthen the Corporation for long term sustainability & to enable the Corporation to raise long term financing in line with its objectives from banks, financial institutions, non-banking financial companies, investors, contributors, capital markets(domestic & international) & others by establishing it under the statute.
- 3. As per the clause 12(4) of the Ordinance No. 14 of 2020, the Government shall assign to the Corporation, the revenue from Additional Retail Excise Tax ("ARET") and shall take such steps as may be required under the applicable laws to give effect to the same including due appropriations by law passed in the State Legislature if required from time to time.
- 4. In the reference 3<sup>rd</sup> read above, the VC&MD, APSDC has inter-alia requested the Government to assign to the Corporation, the revenue from the Additional Retail Excise Tax ("ARET") in terms of the reference 2<sup>nd</sup> read above.
- 5. Government, after careful examination of the matter, hereby assigns the ARET revenues of (10) ten APSBCL Depots remitted under the following Heads of Accounts for escrowing to the Andhra Pradesh State Development Corporation.

- 7. The Cash & Debt Management section of the Finance Department is authorised to manage the above transfer of the ARET Revenues to the APSDC.
- 8. The Director of Treasuries & Accounts and the Finance (Budget wing) Department shall conduct monthly review & reconciliation in order to ensure that receipt and transfer made are in conformity with this G.O.
- 9. The CEO, APCFSS shall make necessary arrangements to facilitate the above mechanism in CFMS.
